Founded in 1897, AIPLA is a national bar association of approximately 7,000 members engaged in private or corporate practice, in government service, and in the academic community. AIPLA members represent a wide and diverse spectrum of individuals, corporations, and institutions involved directly or indirectly in the practice of patent, trademark, copyright, trade secret, and unfair competition law, as well as other fields of law affecting intellectual property. Our members represent both owners and users of intellectual property. 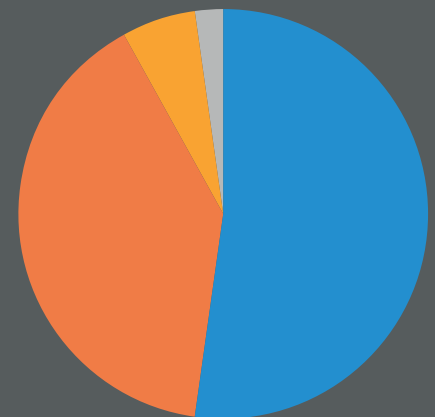
**Membership/Community:** Activities designed to improve membership acquisition and retention and to improve participants' engagement with AIPLA.

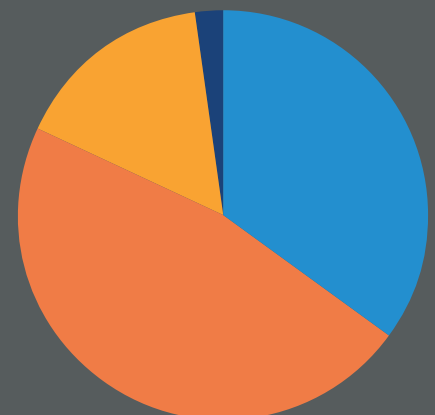

As you may notice, the first letters spell FAME. I am sure you will hear more about changes from the Committees in the coming year. AIPLA is indeed marching into the future and I'm extremely proud of what we've accomplished.

Our committees continue to be the source of much of AIPLA's most important work. I wish to extend thanks to all of the leaders of the committees and to the many, many dedicated members of AIPLA. The level of engagement and quality of the committee work is awesome. On a somewhat related note, one of our newest committees, the Special Committee on Privacy and Data Security will become a regular committee under President - Elect Ann Mueiting. This committee provides a terrific forum for education, outreach, member services, advocacy, and professional development in this important and rapidly advancing field.

We continue to enhance the membership experience at our various meetings. One of the most exciting aspects of working with AIPLA is the variety of high-level events we produce this past year. Our talented headquarters staff and dedicated volunteers held many successful meetings, seminars, boot camps, summits, and roadshows across the country this past year. These meetings help keep our members from the United States and around the world connected and engaged - and for those members that are unable to attend one of our Stated Meetings, an opportunity to learn, obtain CLE, and engage with their colleagues and friends. One final note about AIPLA's Stated Meetings: we will be returning to Washington, D.C. for the Annual Meeting beginning in 2025.

On the advocacy front, our efforts remained strong this year. As noted in previous Annual Reports, advocacy matters because it allows us to proactively impact the direction of IP law and our profession. AIPLA's advocacy also amplifies our individual voices to a level that is heard and understood domestically and internationally. Our advocacy includes engaging with and educating decision-makers to promote outcomes and to increase our impact on legislation, regulations, on national and international policy.

With the support of our Committees, the Association maintained our position as expert advocates for a well-balanced intellectual property system. We helped shape legislation and regulations both domestically and internationally. We continue to track and participate as an amicus in cases before the Supreme Court of the United States and Court of Appeals for the Federal Circuit. This year we also filed an amicus brief in Virginia State appellate court on trade secret damages. We submitted suggestions via comment letters to a variety of U.S. government agencies and foreign IP offices, among others. We completed AIPLA delegation trips internationally to meet and learn about international intellectual property systems, organizations, offices, courts, and enforcement actions.

The Annual Report is hardly the only publication that we produce. Our regular publications include the Quarterly Journal in partnership with the George Washington University Law School, INNOVATE Magazine, eBulletin, daily Lexology, Report of the Economic Survey, the new Quarterly Policy Memo, and others.

In our busy world, we have so many commitments, conflicting priorities, and hectic schedules, but getting together face-to-face at our meetings does so much more than earning CLE credits. Those meetings advance many of the organization's projects, papers, and positions -- as well as develop professional relationships and make friends. So like many AIPLA Presidents before me, I would like to thank all of our members who attended our Mid-Winter Institute in San Diego and the Spring Meeting in Seattle.

Which brings me to our Annual Meeting. This year's event will have great opportunities for learning, networking, collaborating, and reconnecting. We are offering tremendous educational opportunities, high level speakers, and fantastic networking functions. I have no doubt this will be a fun and rewarding event.

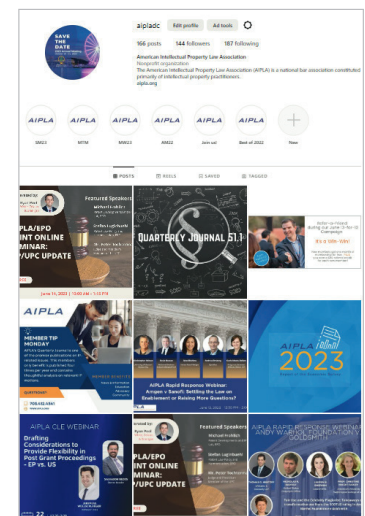

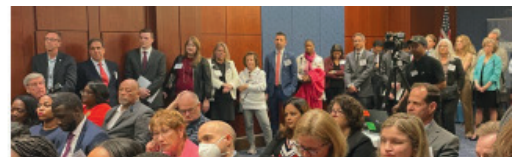
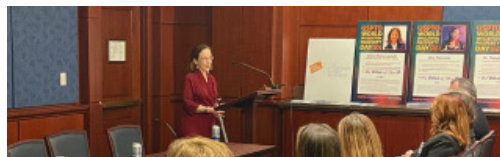

# Advocacy


A longtime pillar of AIPLA, advocacy activities serve the membership by representing members' interests via advocacy with the judiciary, on Capitol Hill, and with relevant government agencies and organizations. While AIPLA headquarters lead and execute on behalf of members, committees play an active and vital role in the development of AIPLA's policy agenda. For example, committees will call attention to potential legislative and amicus issues of importance. Initiatives like legislation tracking, amicus brief development, and drafting position statements, all work toward maintaining a robust and well-balanced IP system and each deliver on and enhance the value of your AIPLA membership.

## Judicial Advocacy

AIPLA has filed numerous amicus briefs in the 2022-2023 year including, *Andy Warhol Foundation for the Visual Arts, Inc. v. Goldsmith*, *Amgen Inc. v. Sanofi*, *Jack Daniel's Properties v. VIP Products LLC*, *Abitron Austria GmbH v. Hetronic International, Inc.*, *Vidal v. Elster*, *LKQ Corp. et al. v. GM Global Tech. Operations LLC.*, as well as a pending brief.

## Capitol Hill

AIPLA continued to be a presence on Capitol Hill, meeting with key policymakers, attending relevant hearings, and advocating for an effective and balanced IP system. Aligned with the Advocacy strategic goal, we work to ensure that policy makers recognize AIPLA as an effective, credible, and useful resource on intellectual property law. For example, AIPLA issued a supportive statement upon the introduction of the Patent Eligibility Restoration Act of 2023.

On the House of Representatives side, our policy team tracked issues and attended hearings on the Right to Repair, Oversight of the USPTO, Artificial Intelligence, and the implementation of the Music Modernization Act. On the Senate side, the team engaged on several issues and monitored hearings on Foreign Competitive Threats to American Innovation and Economic Leadership, and the Intersection of Artificial Intelligence and Intellectual Property. Additionally, we submitted a letter to the Senate in support of Deborah Robinson as the Intellectual Property Enforcement Coordinator (IPEC).



**AIPLA Comments on Federal Trade Commission Non-Compete Clause**  
April 21, 2023  
Arlington, VA. April 21, 2023 - The American Intellectual Property Law Association (AIPLA) submitted comments to the Federal Trade Commission in response to their published notice on Non-Compete Clause Rulemaking, 88 FR 3482, on January 19, 2023. The proposed rule would effectively ban the use of non-competes, with few exceptions.



**AIPLA Comments on USPTO Initiatives to Ensure the Robustness and Reliability of Patent Rights**

Arlington, VA. February 8, 2023 - The American Intellectual Property Law Association (AIPLA) submitted comments to the United States Patent and Trademark Office's ("The Office") Request for Comments on possible initiatives of the Office to ensure the robustness and reliability of patent rights.

## Government Agencies

AIPLA continued to be a prominent voice with the U.S. Patent and Trademark Office, U.S. Copyright Office, and other relevant agencies and courts. In the past 12 months, AIPLA submitted over 25 comments to various agencies. The subjects include the USPTO's Advance Notice of Proposed Rulemaking (ANPRM), Trademark and Patent Fee Setting and Adjusting Proposal to the TPAC and PPAC, Robustness and Reliability of Patents, DOCX, Patent Pro Bono Programs, AI and Inventorship, EPO Guidelines for Examination, FTC Non-Compete Clause, and more. # International Outreach

AIPLA continued its advocacy work internationally, participating in the WIPO General Assembly in Geneva, in the IP5 Heads of Office Meeting in Hawaii, the TM5 and ID5 Meetings, the Trilateral Offices Meeting with Industry in Munich, as well as issuing several comments, such as letters to China's State Administration of Market Regulation and to the EU on Standard Essential Patents.

## IP Practice in Israel

The IP Practice in Israel Committee held a webinar in conjunction with the Emerging Technologies Committee and was pleased to participate in the Women in IP Committee's Global Networking Event. The Committee continued distributing monthly bulletins to committee members regarding any IP/Israel-related events.

## IP Practice in China

The IP Practice in China Committee serves AIPLA members interested in IP in China, facilitating connections with Chinese IP professionals and studying Chinese IP law. Their current projects include collaborating with the USPTO, participating in Global Sector Leadership conferences, and engaging with other committees to provide input on Chinese IP matters. They also hold monthly meetings to discuss Chinese IP law changes and have previously submitted comments on anti-monopoly guidelines in partnership with other committees. Future plans include a potential 2024 AIPLA trip to China, pending geopolitical conditions.

## IP Practice in the Far East

The IP Practice in the Far East Committee completed its delegation to Vietnam and Korea, led by co-chairs **Thomas Treutler** and **Toby Mak**, together with AIPLA President **Brian Batzli** and Immediate Past President **Patrick Coyne**, with a total of 14 delegates. In Vietnam, the delegation visited the AmCham, Vietnam IP Association, and the Vietnam IP Office. In Korea, the delegation visited the KIPO, Korean IP High Court, KNIPA (an industrial IP in-house in Korea), and KPAA. There were fruitful exchanges between the delegation and the visited parties, including updates on the Vietnamese and Korean practice, and the updates on the US practice by the delegation to the visited parties.

## IP Practice in Japan

The IP Practice in Japan Committee, led by co-chairs **Don Studebaker** and **Kevin Kundendorf**, completed its annual delegation trip to Japan in April, made more memorable since it was the first trip post-pandemic. The committee met with the JPO, AIPPI/JFBA, US Embassy, LES-J, Women in IP, JPAA, IP High Court, JTA and JIPA. Some highlights of the trip included meeting with JPO Commissioner Hamano, a visit to the new IP High Court facility in Naka-Meguro, well-received panel discussions on parody with the JTA and law practice under the work-from-home system, and a mock presentation on how Japanese stakeholders can be more involved in US litigation. Substantively, the topic of the trip was AI – both substantive patenting of AI-related inventions and its potential effects on law firm practice – with almost every organization having an AI topic component. Additionally, there were comparative law discussions from high-profile trademark cases to enforcement of IP in a digital world, cross-border infringement, and international patent exhaustion. The trip culminated in a well-attended reception at the Roppongi Hills Club. The delegation was joined by Board Member **Todd Baker** and Immediate Past President, **Patrick Coyne**.

## IP Practice in Europe

The IP Practice in Europe Committee, led by co-chairs **Ryan Pool** and **Elisabetta Papa**, organized a trip focused on meetings with IP authorities, namely the EPO, WIPO, UPC (Munich Local Division) and EUIPO. In six days, the delegation-including Immediate Past President **Patrick Coyne** and President-Elect **Ann Muetting**—visited Germany, Switzerland, and Spain, in each country discussing relevant IP issues about development of law and practice.

## IP Practice in Latin America

While in Panama, the delegation, led by co-chairs **Edwin Molino** and **Ignacio Sanchez**, held meetings with the Panamanian Supreme Court, the U.S. Embassy, Director of the Copyright Office, the Panamanian IP Associations—which organized a Women in IP Law Breakfast—and much more. In Costa Rica, the delegation met with the Directors of the Costa Rican National Registry, which includes The Patent and Trademark Office and the Copyright Office, the five Justices of the Administrative Court of Appeals, the American Chamber of Commerce, the U.S. Embassy, Civil Court Superior Judge, and District Attorney. The trip was joined by AIPLA President **Brian Batzli**, and Immediate Past President **Patrick Coyne**.

## AIPPI-US

The AIPPI-US was originally founded as a non-profit organization in 1930 and has approximately 300 members. Membership in AIPPI-US automatically includes membership in AIPPI. The United States has one of the largest representations on the International Executive Committee – the principal decision-making body of AIPPI.

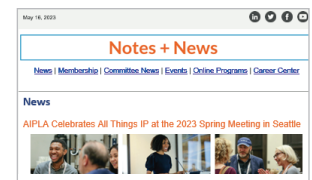


## AIPLA Newsstand
